1. Roll Call/Establish a Quorum

2. Reserve/Finance Approval/Update

- o Treasurer Eugene Marisa provided an update on the finances.
 - Cash on hand: \$43,000

• Reserve deficit: \$3,500 after transfers to reserves

 Eugene questioned the difference in the balance sheet, which shows \$72,651.96 in outstanding HOA fees, while Sunvast only accounted for \$59,430.

3. Late Fee Collection Plan

- The motion was not seconded and therefore failed.

7. Coupon Book Elimination

8. Playground Update
